The distribution of securities to private investors is carried out by linking direct banks and branch banks as retail brokers in the respective syndicate, youmex acts as transaction manager of the placement syndicate for bond issues and IPOs as well as for re-placements of shares and capital increases to investors. In the fixed income segment, youmex acts as placement coordinator and organizes the sales force to place bearer bonds, convertible bonds and profit participation certificates

Securities-Services

The youmex group infrastructure can also be used to offer the securities services required for issues and exchange trading, such as:

- Structuring and creation of (convertible) bonds, profit participation certificates, funds, certificates and other structured products
